REMOTE PARTICIPATION AND VOTING FACILITIES

In view of the COVID-19 health concerns, the 42nd AGM of the Company will be held on a virtual basis through live streaming and online remote voting at the Broadcast Venue using the Remote Participation and Voting Facilities (“RPV”) to be provided by the Company’s Share Registrar, Tricor Investor & Issuing House Services Sdn Bhd (“Tricor”) via TIIH Online website at <https://tiih.online>.

As the COVID-19 situation in Malaysia is constantly evolving, we may be required to change the arrangements for the 42nd AGM at short notice. Please visit Bursa Malaysia Securities Berhad’s website or the Company’s website at <https://www.gentingmalaysia.com/agm/> for the latest announcements relating to the 42nd AGM.

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the Chairperson of the meeting shall be present at the main venue of the meeting. Members **WILL NOT BE ALLOWED** to attend the 42nd AGM at the Broadcast Venue in person on the day of the meeting.

Members are to attend, speak (in the form of typed text messages) {attend and speak (in the form of typed text messages) are collectively, “participate”} and vote remotely at the 42nd AGM using the RPV to be provided by Tricor via its **TIIH Online** website at <https://tiih.online>.

PRE-MEETING SUBMISSION OF QUESTIONS TO THE BOARD OF DIRECTORS

Members may submit questions relating to the ordinary and special businesses set out in the Notice of the 42nd AGM to the Board in advance of the 42nd AGM via Tricor’s TIIH Online website at <https://tiih.online> by selecting “e-Services” to login, pose the questions and submit electronically not later than **Tuesday, 31 May 2022 at 10.00 a.m.** or during live streaming on the day of the 42nd AGM itself by typing the question in the query box via the RPV.

Priority will be given to questions which are submitted ahead of the 42nd AGM. If time permits during the meeting, the Board will try to respond to those relevant questions relating to the businesses to be discussed at the 42nd AGM which are submitted via the RPV during live streaming.

Questions which are not related to the 42nd AGM will not be answered by the Board.

MEMBER WHO IS AN INDIVIDUAL PERSON

A member who is an individual person and wishes to participate and vote remotely at the 42nd AGM of the Company via the RPV must pre-register as a user with TIIH Online. If the member is already a user with TIIH Online, the member is not required to register again.

Upon successful notification of registration as a user with TIIH Online, the member must submit his/her request for “**Registration for Remote Participation and Voting**” at <https://tiih.online> in order to participate and vote at the 42nd AGM via the RPV.

PROXY/(IES)

Members may appoint proxy/(ies) to participate and vote via the RPV at the 42nd AGM of the Company. The appointment of proxy/(ies) may be made in a hard copy form or by electronic means.

For hard copy form submission, the original instrument appointing a proxy shall be in writing and:

- (a) in the case of an individual, shall be signed by the appointor or by his attorney; and
- (b) in the case of a corporation, shall be either under the common seal or signed by its attorney or by an officer on behalf of the corporation.

Duly executed proxy forms must be submitted in the following manner, not less than forty-eight (48) hours before the time appointed for holding the 42nd AGM or at any adjournment thereof:

(i) In hard copy form

The **original** signed proxy form must be deposited with Tricor at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or alternatively, at Tricor’s Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia (“Tricor’s Office”).

(ii) Via Tricor Online System (TIIH Online)

The proxy form can be electronically submitted via TIIH Online at <https://tiih.online>. Please refer to the procedures set out in “**ELECTRONIC LODGEMENT OF PROXY FORM ONLY**” below.

Members are requested to provide their mobile handphone numbers as well as the mobile handphone numbers of their proxies in the proxy forms in the event Tricor needs to contact the members/proxies.

The last date and time for the deposit/electronic submission of the proxy forms is **Tuesday, 31 May 2022 at 10.00 a.m.**

The appointed proxy must register himself/herself for the RPV at <https://tiih.online> in order to participate and vote at this 42nd AGM via the RPV. For further details, please refer to the **PROCEDURES FOR THE RPV (BEFORE THE DAY OF THE AGM AND ON THE DAY OF THE AGM)**.

CORPORATE MEMBERS

A Corporate Member who wishes to appoint a Corporate Representative to participate and vote remotely at the 42nd AGM of the Company via the RPV must deposit the **original** certificate of appointment of corporate representative (in hard copy) to Tricor’s Office.

The certificate for appointment of corporate representative must be either under seal or signed by a duly authorised officer(s) pursuant to a resolution of its board of directors.

If a Corporate Member submits more than one (1) certificate of appointment, the latest certificate of appointment shall supersede the certificate of appointment which is submitted earlier.

Corporate Members are requested to provide their contact details of their officers (office/mobile handphone numbers) as well as the mobile handphone numbers of their corporate representatives in the event Tricor needs to contact them.

The appointed Corporate Representative must register himself/herself for the RPV at <https://tiah.online> in order to participate and vote at this 42nd AGM via the RPV. For further details, please refer to the **PROCEDURES FOR THE RPV (BEFORE THE DAY OF THE AGM AND ON THE DAY OF THE AGM)**.

NOMINEE COMPANIES

For a Nominee Company registered as a member, the beneficial owner of the shares held under a Nominee Company's CDS account who wishes to participate and vote remotely at the 42nd AGM of the Company via the RPV can request the Nominee Company to appoint him/her as a proxy and deposit the duly completed **original** Proxy Form (in hard copy) at Tricor's Office or submit electronically via TIIH Online at <https://tiah.online> not later than **Tuesday, 31 May 2022 at 10.00 a.m.** For online submission, please refer to the procedures set out in "ELECTRONIC LODGEMENT OF PROXY FORM ONLY" below.

Nominee Companies are requested to provide their contact details of their officers (office/mobile handphone numbers) as well as the mobile handphone numbers of the proxies in the event Tricor needs to contact them.

The appointed proxy of the Nominee Company must register himself/herself for the RPV at <https://tiah.online> in order to participate and vote at this 42nd AGM via the RPV. For further details, please refer to the **PROCEDURES FOR THE RPV (BEFORE THE DAY OF THE AGM AND ON THE DAY OF THE AGM)**.

APPOINTMENT OF MORE THAN ONE (1) PROXY

Where a member appoints more than one (1) proxy, the appointments shall be invalid unless he/she specifies the proportions of his/her shareholding to be represented by each proxy. If a member submitted more than one (1) proxy form, the latest proxy form shall supersede the earlier one.

REVOCATION OF PROXIES OR VICE VERSA

If a member submitted a proxy form appointing his/her proxy, the proxy appointment can be revoked should the member decide to personally participate at the 42nd AGM of the Company via the RPV. Please contact the persons stated under "ENQUIRY" section below not later than **Tuesday, 31 May 2022 at 10.00 a.m.** to request for revocation. However, if a member who has registered to participate via the RPV for the 42nd AGM subsequently wishes to appoint his/her proxy to participate on his/her behalf, please contact the persons stated under "ENQUIRY" section below and deposit the proxy form not later than **Tuesday, 31 May 2022 at 10.00 a.m.**

MEMBERS WHO ARE UNABLE TO ATTEND MAY APPOINT THE CHAIRMAN OF THE MEETING

As the 42nd AGM is to be held virtually, members who are unable to participate at the 42nd AGM may appoint the Chairman of the meeting as his/her/its proxy and indicate the voting instructions in their proxy forms and submit either in a hard copy form or by electronic means in the manner set out under "PROXY/(IES)" above, not later than **Tuesday, 31 May 2022 at 10.00 a.m.**

DATE OF RECORD OF DEPOSITORS FOR DETERMINING ENTITLEMENT TO ATTEND THE 42ND AGM

Only depositors whose names appear on the Record of Depositors as at 24 May 2022 shall be entitled to attend the 42nd AGM or appoint proxies to participate and vote on their behalf.

PROCEDURES FOR THE RPV

Members/proxies/corporate representatives who wish to participate at the 42nd AGM remotely using the RPV must follow the following requirements and procedures:

BEFORE THE DAY OF THE AGM		
(a)	Register as a user with TIIH Online	- Using your computer, access the website at https://tiah.online. Register as a user under the "e-Services", select "Create Account by Individual Holder". Please refer to the tutorial guide posted on the homepage for assistance. - Registration as a user will be approved within one (1) working day and you will be notified via email.

(a)	Register as a user with TIIH Online (cont'd)	- Please allow sufficient time for approval of new user of TIIH Online. - If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail from Tricor to notify you that the remote participation for the 42nd AGM is available for registration at TIIH Online.
(b)	Submit your request	Registration is open from Thursday, 7 April 2022 until the day of the 42nd AGM on Thursday, 2 June 2022. Members or proxies or corporate representatives are required to pre-register their attendance for the 42nd AGM to ascertain their eligibility to participate at the 42nd AGM using the RPV. Although the TIIH Online is open for registration until the day of the 42nd AGM on Thursday, 2 June 2022, please allow sufficient time for approval of registration for the RPV. As such, members or proxies or corporate representatives are encouraged to submit the registration no later than Tuesday, 31 May 2022 at 10.00 a.m. to facilitate verification of your registration as set out in the last bullet point below. - Login with your user ID (i.e. e-mail address) and password and select the corporate event: “(REGISTRATION) GENTING MALAYSIA BERHAD 42ND AGM”. - Read and agree to the Terms & Conditions and confirm the Declaration. - Select “Register for Remote Participation and Voting”. - Review your registration and proceed to register. - System will send an e-mail to notify that your registration for remote participation is received and will be verified. - After verification of your registration against the General Meeting Record of Depositors as at 24 May 2022, the TIIH system will, on or after 31 May 2022, send you an e-mail to approve or reject your registration for remote participation.

(c)	Login to TIIH Online	Login with your user ID (i.e. e-mail address) and password for remote participation at the AGM at any time from 9.00 a.m. i.e. one (1) hour before the commencement of the 42nd AGM on Thursday, 2 June 2022 at 10.00 a.m.
(d)	Participate through Live Streaming	- Select the corporate event: “(LIVE STREAM MEETING) GENTING MALAYSIA BERHAD 42ND AGM” to engage in the proceedings of the 42nd AGM remotely. - If you have any question for the Chairman/Board, you may use the query box to transmit your question. If time permits, the Chairman/Board will try to respond to those relevant questions relating to the businesses to be discussed at the 42nd AGM which are submitted by remote participants during the 42nd AGM. You are encouraged to submit questions before the 42nd AGM as priority will be given to questions submitted before the 42nd AGM – see “PRE-MEETING SUBMISSION OF QUESTIONS TO THE BOARD OF DIRECTORS”.

(d)	Participate through Live Streaming (cont'd)	Take note that the quality of the live streaming is dependent on the bandwidth and stability of the internet connection at the location of the remote participants.
(e)	Online Remote Voting	- Voting session commences from 10.00 a.m. on Thursday, 2 June 2022 until a time when the Chairman announces the completion of the voting session of the 42nd AGM. - Select the corporate event: “(REMOTE VOTING) GENTING MALAYSIA BERHAD 42ND AGM” or if you are on the live stream meeting page, you can select “GO TO REMOTE VOTING PAGE” button below the Query Box. - Read and agree to the Terms & Conditions and confirm the Declaration. - Select the CDS account that represents your shareholdings. - Indicate your votes for the resolutions that are tabled for voting. - Confirm and submit your votes.
(f)	End of remote participation	Upon the declaration of the poll results and announcement by the Chairman on the closure of the 42nd AGM, the live streaming will end.

NOTE TO USERS OF THE RPV:

- Should your application to join the meeting be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

POLL VOTING

The voting at the 42nd AGM will be conducted by poll in accordance with Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad. Tricor will conduct the poll by way of electronic voting (e-voting).

Shareholders/proxies/corporate representatives can proceed to vote on the resolutions at any time from the commencement of the 42nd AGM at 10.00 a.m. on 2 June 2022 but before the end of the voting session which will be announced by the Chairman of the meeting. Kindly refer to item (e) of the above Procedures for the RPV for guidance on how to vote remotely from TIIH Online website at <https://tiih.online>.

Upon completion of the voting session for the 42nd AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration on whether the resolutions are duly passed.

(i)	Register as a User with TIIH Online	• Access TIIH Online at https://tiih.online. • Under e-Services, the authorised or nominated representative of the corporation or institutional members selects “Create Account by Representative of Corporate Holder”. • Complete the registration form and upload the required documents. • Registration will be verified, and you will be notified by email within one (1) to two (2) working days. • Proceed to activate your account with the temporary password given in the email and re-set your own password. Note: The representative of a corporation or institutional member must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact the persons stated under “ENQUIRY” section below if you need clarifications on the user registration.
